▶ How Can You Support?

▶ Do employee donors receive recognition?

Yes! You matter and we appreciate all you do. Employees will be recognized on the donor wall in our new inpatient and dietary wing and on the hospital monitor in the Administration hallway.

▶ What should you give?

Any amount! All donations add up to big results! For payroll deduction, there is a minimum of \$2 per pay check or four hours paid time off donated. See the giving guide below. All contributions are tax deductible to the amount permitted by law.
